Career Highlights

As **Deputy CIO for GIS at the City of Chicago**, Ms. Mangan led the transformation from desktop cartography to integrated, pervasive technology. Through the design and development of sophisticated data models, application architecture, and web services, the GIS Division can now incorporate GIS functionality into any enterprise system.

Ms. Mangan also led the strategy and design for the City's GPS Tracking system, which in 2007 was monitoring over 4000 assets every 30 seconds. She and her team developed applications that included automated field ticketing, real-time emergency incident analysis, insect-borne disease tracking, and dynamic mapping of enterprise activity related to work orders and permits. Two of these initiatives received awards from the Public Technology Institute.

Beyond her role in GIS, Ms. Mangan facilitated the development of an IT Strategic Plan for the Department of Innovation & Technology. She also advised and supported the departments of Transportation, Streets and Sanitation, and Fleet Management with system implementations and technology planning.

As **eGovernment Practice Director for Chicago Systems Group**, Ms. Mangan generated over \$9 million in revenue from government clients at the state, county, and local levels in its first two years. Ms. Mangan established the methodology and approach for strategic planning projects delivered by the firm and led the development of strategic technology plans for the Cook County Family Law Bureau, the Circuit Court of Cook County, and the Illinois Department on Aging.

As a **Senior Consultant with Computer Sciences Corporation**, Ms. Mangan was part of a nationwide Delivery Assurance Review team. This team assessed the performance of consulting engagements throughout the corporation. Ms. Mangan also managed strategic planning, systems analysis, and application development projects for state and county clients.

As an **Advisory Consultant with IBM**, Ms. Mangan traveled extensively to Kuwait and Paris to participate in design workshops with representatives of each military branch. Ms. Mangan was the primary designer for a multi-country procurement system.
